Types of Personal Data we process:

HOW WE COLLECT

We collect the information mentioned above directly from you through the following ways directly from you:

1. When an enquiry or booking is made either via the telephone, our website, email or social platforms
2. If you enter a promotion advertised on our website or social platforms
3. If you engage or follow us on any social platforms
4. When you subscribe to receive our monthly newsletters via email
5. If you are to ever communicate with us for any reason

However, we can also collect data by using technical means whenever you use our website.

HOW WE PROCESS YOUR PERSONAL DATA
